Invitation For Quotation

Upgrade and Completion of Drilling Rig No. 6 (850 HP)

1. Introduction

The National Oil Wells Drilling and Workover Company (NWD), a wholly owned subsidiary of the National Oil Corporation of Libya (NOC), hereby invites **qualified and reputable international companies** to submit proposals for the **upgrade, certification, and completion of Drilling Rig No. 6 (850 HP capacity)**.

Rig No. 6 is currently out of service pending upgrades, certification, and the procurement of essential spare parts and components. The objective of this tender is to engage a **strong and reliable partner** to return the rig to safe and efficient operational conditions in compliance with **international standards and industry's best practices**. Under this arrangement, NWD will provide the rig along with the contract, while the successful bidder shall supply and install the missing components.

2. Scope of Work

The successful bidder shall be responsible for:

1. Technical Assessment

- Conducting a comprehensive evaluation of the current condition of Rig No. 6.
- Preparing a detailed technical report outlining required equipment, spare parts, and upgrades.

2. Supply & Installation

- Provision and installation of all missing and defective equipment and systems.
- Ensuring compatibility and certification of supplied parts in accordance with **API and international standards**.

3. Certification & Compliance

- Facilitating the rig's certification process by recognized international bodies.
- Ensuring compliance with applicable **safety, environmental, and operational standards**.

4. Commissioning & Operational Readiness

- Supporting rig commissioning and start-up.
- Ensuring full operational readiness for deployment in drilling operations.

3. Partnership Framework

The selected bidder will enter into a **joint participation agreement** with NWD under the following conditions:

- NWD will guarantee a **work contract** for Rig No. 6 for a mutually agreed period after completion of the upgrade.
- Recovery of the cost of equipment, services, and the partner's profit margin will be affected through the rig's **daily operating rate**, directly allocated from the end client.
- Upon full recovery cost, the installed and upgraded equipment shall remain permanently with Rig No. 6.
- NWD and the partner may negotiate **extended cooperation** beyond the cost recovery period.

4. Eligibility Criteria

Bidders must demonstrate:

- Proven experience in **rig upgrade, refurbishment, or certification projects** (preferably for land rigs of 750 HP and above).
- Strong financial capability to undertake the required scope.
- Compliance with **international quality, health, safety, and environmental standards (QHSE)**.
- Availability of qualified personnel and experts for site visits and project execution.

5. Site Visit & Clarifications

- Interested bidders may nominate **technical experts** to conduct a site visit to assess the rig's current status.
- Requests for clarifications must be submitted in writing no later than **20/09/2025**.

6. Submission Requirements

Bidders must submit proposals in two separate sealed envelopes:

1. Technical Proposal

- Company profile, relevant experience, and references.
- Methodology for upgrade and certification.
- List of equipment, spare parts, and services to be provided.

- Project execution schedule.

2. Commercial Proposal

- Detailed cost breakdown for equipment, services, and manpower.
- Proposed cost recovery structure and profit margin.

Both envelopes must be clearly marked and delivered to NWD Headquarters no later than **01/10/2025**.

7. Evaluation Process

Proposals will be evaluated based on:

- Technical compliance with the scope of work.
- Relevant company experience and expertise.
- Financial offer and cost recovery structure.
- Project execution timeline.
